# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to dream amazing travel, and Dream Amazing Travel LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Dream Amazing Travel LLC include dream amazing travel and Dream Amazing Travel LLC. ## **Collection of your Personal Information**

We do not collect any personal information about you unless you voluntarily provide it to us.
